 - 6 SEC. 2. CLARIFICATION OF TREATMENT OF BUSINESS EX-
 - 7 PENSES.
 - 8 (a) In General.—Subsection (i) of section 1106 of
 - 9 the CARES Act (Public Law 116–136) is amended—
